### Objective

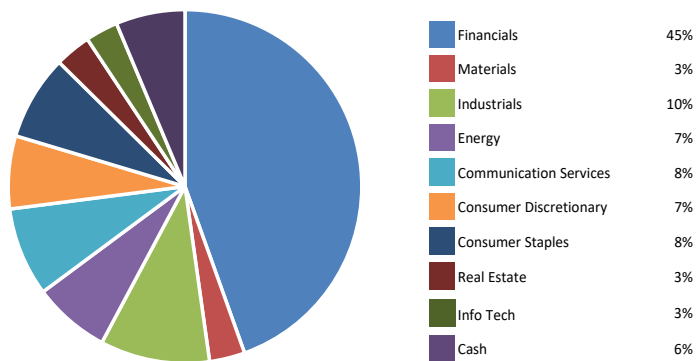

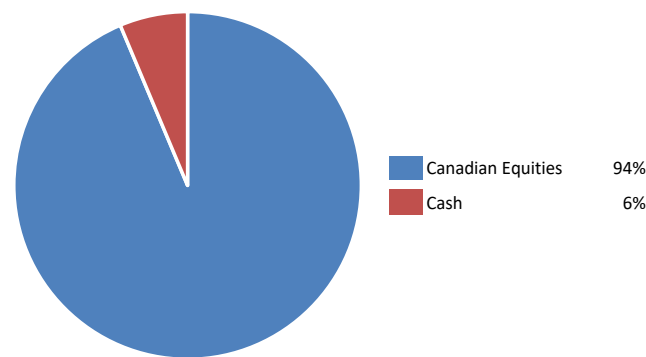
