Objective

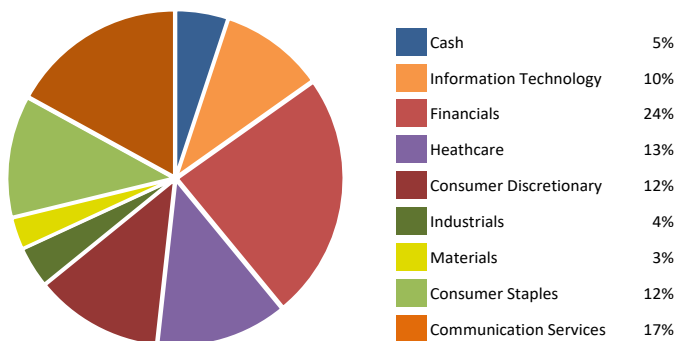

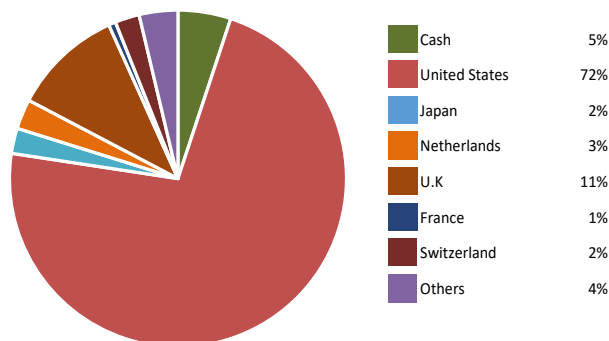
